Results of Annual General Meeting held 30 October 2023

Godolphin Resources Limited (ASX: GRL) today held its 2023 Annual General Meeting. All resolutions put to the meeting were passed by a poll.

Resolution 5 was withdrawn.

It was decided that it is commercially preferable for the Company to hold a subsequent general meeting of shareholders, and then seek shareholders' approval for issuing the Consideration Shares, at a time nearer to an election being made in respect of Stage 2 when there is more assurance about the Company's share price at the time of the election. Godolphin Resources (ASX: GRL) is an ASX listed resources company, with 100% controlled Australian-based projects in the Lachlan Fold Belt ("LFB") NSW, a world-class gold-copper province. A strategic focus on critical minerals and green metals through ongoing exploration and development in central west NSW. Currently the Company's tenements cover 3,400km² of highly prospective ground focussed on the Lachlan Fold Belt, a highly regarded province for the discovery of REE, copper and gold deposits. Additional prospectivity attributes of GRL tenure include the McPhillamys gold hosting Godolphin Fault and the Boda gold-copper hosting Molong Volcanic Belt.

Godolphin is exploring for REE, structurally hosted, epithermal gold and base-metal deposits and large, gold-copper Cadia style porphyry deposits and it is pleasing to continue a re-focus of exploration efforts for unlocking the potential of its East Lachlan tenement holdings, including increasing the mineral resource of its advanced Lewis Ponds Project.
